## Public Transport Depot Project – Construction of Shegole and Kality Depots in Addis Ababa City

### Sector: Public Transport Sector

- 1. The Addis Ababa City Administration has allocated sufficient budget towards the cost of constructing and furnishing Shegole and Kality Depots and intends to apply part of the proceeds to eligible payments for the construction works.
- 2. The project is a depot construction which comprises various facilities used for public transport vehicles. The facilities include parking, washing bay, maintenance workshop, fuel dispenser and head office building.

The period of construction is 18 months, including 45 calendar days of mobilisation period.

- 3. The Transport Programs Management Office (TPMO) now invites eligible bidders, which fulfill the following requirements, to submit Expression of Interest (EOI) for the construction project mentioned in item(1):
  - a. The bidders shall have a certificate of registration from Ministry of Works and Urban Development with Category GC-I renewed for at least 2008 E.C. and other appropriate documentary evidences demonstrating the bidder's compliance which shall include:-
  - ii. Its trading licence renewed for at least 2008 E.C;
  - iii. Its tax clearance certificate valid at least at bid submission date that permits the bidder to participate in any public tender, and VAT registration certificate; and
  - iv. Registration as supplier in the list of the mandated public body, i.e. Public Procurement and Property Administration Agency (PPPAA)
  - b. In case of bidders other than Ethiopians; Business Organization Registration Certificate or Trade License issued by the Country of establishment.
- 3. Bidding will be conducted through the International Competitive Bidding (ICB) procedure, specified in the bidding documents, and is open to all eligible bidders.
- 4. Expression of Interest shall be submitted in English.
- 5. The Client will prepare a short list of about seven candidates to be pre-selected on the basis of the expressions of interest received, to whom the Client will send a Request for Tender (RFT). The tentative schedule for submission of RFT is February 9th, 2015 the latest.
- 6. The following criteria will be used to assess the Expression of Interest documents;Eligibility.
  - General Construction Experience.
  - □ Specific Construction Experience.
  - Specific Construction experience in key activities.
  - Equipment for the implementation of the contract.
  - Financial standing of the bidder for the last 5 (five) years such as, historical financial performance, the annual construction turnover (ACT) of the firm and financial resources (liquid asset/cash flow requirement (CF), unencumbered real assets, lines of credit and so on).
  - Number of similar projects completed successfully by the firm over the last five years.
  - □ Historical contract non performing records.
  - D Pending litigation.
